RE: Panic Devices

At the Human Resources Meeting held on Monday, December 9th, we were told that some Business Agents have informed Hotels that the Union must approve the panic device system selected by the Hotel and that the Union Business Agent or Vice President must observe a trial of the device system in order to obtain Union approval. We have repeatedly told Hotels that this is not the case.

We have confirmed with Union leadership that Union approval is not required so long as the panic device system meets the requirements of IWA Article 70:

(B) Devices

"... the EMPLOYER will equip Room Attendants, Housekeeping Attendants, Minibar Attendants, Room Service Servers and any other employee who is required to enter an occupied guest room with devices to be carried on their persons at work that they can quickly and easily activate to effectively summon prompt assistance to their location. It is recognized that because of the varying size and physical layout of each hotel, different devices may be appropriate for different hotels."

and further satisfies the following:

- 1. Signal location only after the device has been activated by the employee;
- 2. Identify location within the guest room, subject to technological and building limitations;
- 3. Allow the employee to see or hear confirmation that the signal from the device has been transmitted;
- 4. Allow the employee to know the device is connected;
- 5. Conduct a site survey to determine frequency density; and
- 6. Conduct routine testing of systems and devices.

We attach herein a suggested notification letter to the Union apprising them of the system selected by the Hotel.
