**RE:** Division A Collective Bargaining Agreement ("CBA"): July 1, 2014 Wage and

Wage-Related Increases; Increase to Pension Fund Contributions

There is an adjustment called for under the CBA to take effect on July 1, 2014. On that date, each employee on the Employer's payroll shall receive a wage increase of 4% of the employee's actual rate of pay in effect on that date, as follows:

As a reminder, effective January 1, 2014, employees who have been continuously employed for at least one (1) year shall be entitled to a total of eight (8) sick days per year.

Finally, effective July 1, 2014, contributions to the Pension Fund will increase by one-half percent (0.5%), from 6.5% to 7%.
