RE: New Fair Credit Reporting Act (FCRA) Forms for Employers

We wanted to apprise you about regulations regarding new FCRA forms, as follows:

As of January 1, 2013, employers, Credit Reporting Agencies, and furnishers of information must begin using updated versions of the following forms:

- 1. Summary of Your Rights Under the Fair Credit Reporting Act
- 2. Notice to Users of Consumer Reports of their Obligations under the FCRA
- 3. Notice to Furnishers of Information of their Obligations under the FCRA

The only differences on the new forms are that they direct questions to the Consumer Financial Protection Bureau instead of the Federal Trade Commission. Otherwise, they remain substantively similar to the previous forms, and must be provided under the same circumstances as before. The "Summary of Your Rights Under the Fair Credit Reporting Act" is the most relevant of the above forms for employers, since employers must provide this summary along with a copy of the consumer report before taking any adverse employment action against the employee or applicant. The remaining two forms are for Credit Reporting Agencies to provide to users of their services and furnishers of information.
